NOMINATING PROCEDURES

Method of Nominating: The method of submitting a nomination will be on the Feedback Form located on the Super Liga website, www.thesuperliga.com. All information on the feedback form must be filled in. Click the "Feedback" tab on the front page of the web site and the "*Select type of feedback*", select "*General Comments*" and in the message block, type in the award you are nominating someone for, the person's name, the reason why that person is deserving of the award and what association the nominating person is from.
